Temporary Outdoor Business Operation permits expire!



July 13, 2022 – When the Temporary Outdoor Business Operations permits expire!

Please make sure you are in compliance. Recently, we talked with Chris Larson from DSD about the TOBO permits (Temporary Outdoor Business Operations.) He told us that all TOBO Permits expire on July 13, 2022. Business owners must meet all applicable requirements under Spaces as Places for outdoor business operations past this date.

If you haven't already applied for the Spaces as Places permit, please start now. They have a checklist for you to follow. You should have received a 45 day notice to remove your outdoor temporary operation from the City if you have an existing TOBO permit. It is our understanding that the Property Owner will be the one who signs any permits for Streetaries. This will be recorded on the Title of the property.

As a special note, you all are probably familiar with the coastal zones. In Ocean Beach, Sunset Cliffs Blvd. to the west (ocean) is the area designated as the coastal zone. The Coastal Commission has not yet made a decision on whether they will allow Spaces as Places permits in the Coastal Zone.

Outdoor Dining on private property like a parking lot will need to get a building permit from DSD. This can be a lengthy process. Again, the Coastal Commission may have to rule on this allowance to remove existing parking on private property within the coastal zone.

If you are planning on keeping your outdoor space, please make sure you go to the City's website and do your research to make sure you will be in compliance. We found that Chris Larson was very helpful and his email is <u>clarson@sandiego.gov</u> should you have any further questions.

Sidewalk Vending Ordinance

The new ordinance passed through the second reading at San Diego City Council Meeting and was signed by the Mayor on Thursday May 19th. The City will be educating and enforcing the new regulations no later than June 19th. As we found out, some of the provisions must receive additional approval at the Coastal Commission which we hope will be completed in the next couple of months. In the meantime, many parts of the ordinance will be enforced beginning in mid-June.

Many thanks to all of you who helped get this vending ordinance to the City Council by speaking at committee and council meetings and by writing emails and sending photos to our councilperson. We have been working on this issue since June of 2019 so it has taken a very long time to even get to this point. Our City Councilperson, Jen Campbell and her Chief of Staff, Venus Molina brought this ordinance to City Council and we want to thank them for hanging in there and seeing it through to this point.

Ocean Beach Fireworks & Pier Update

Ocean Beach Fireworks won't be happening this year but the pier will be open!

Normally we would be picking out the type of fireworks we are going to have this July 4th but we are sorry to say we won't be hosting the fireworks again this year. We need at least 6-9 months to raise money, get permits and sign contracts with the fireworks company. With all the uncertainty regarding the pier, we won't have enough time. The pier was very recently reopened but there are still structural weaknesses from old age. We need to access the pier with trucks loaded with fireworks and that just isn't prudent or allowed at this point in time.

Many thanks to the City and the Mayor's office for pushing to get the sewer line fixed on the pier and reopen it for summer. The Mayor also announced the beginning of City's effort to redesign the pier with a long term goal of replacing the pier with one that can last 75-100 years. More to come on this!
